## **General Terms & Conditions:**

- 1 CCB will organize counseling and admission for the students in NSU, Jamshedpur Campus Only. Students should be admitted from the same location, city, state of the institutions.
- 2 First party will pay service charge to the second party against each confirmed admission. \*Confirmed admission means any students submit his/her original documents and pays 1st semester college fee. Or minimum deposit of the amount (including college fee and hostel fee) equal to service charge of second party. Number of students must not be manipulated by the staff of 1st party.
- 3 It is whole n sole responsibility of 1st Party to recover the fee of 1st semester from the students and give them an ultimatum to deposit their fee before starting their classes.
- 4 Second Party is entitled to take service charge per student in UG and PG Course. (Note: If more than 10students taken admission in any of the course then service charge will raise accordingly.
