## University Animals Ethics Committee (UAEC)

Research and experimentation on animals are covered by provisions of the Prevention of Cruelty to Animals Act (PCA), 1960 (amended in 1982) and Rules of Breeding of and Experiments on Animals (Control & Supervision) 1998 (amended in 2001 and 2006) framed under the PCA, 1960. Government has constituted a Committee for the Purpose of Control and Supervision of Experiments on Animals (CPCSEA) under the provision of Section 15 of PCA Act 1960.

University Animal Ethics Committee (UAEC) of NSU has been empowered to permit experiments on small animals through an amendment in Rules for Breeding and Experiments on Animals (Control and Supervision) in year 2006. NSU possess a well-established Animal House registered with CPCSEA. NSU adhere scrupulously to the guidelines provided by the CPCSEA.

The main functions of University Animal Ethics Committee (UAEC) of NSU are as prescribed in "Breeding of and Experiments on Animals (Control and Supervision) Rules, 1998": Specifically, the committee confirms the quality and consistency of research proposals submitted by the eligible researchers and prevents infliction of unnecessary pain & sufferings before, during and after experiments on animals, by provided by CPCSEA. following the guidelines 08/07/1957.
