Reservation Policy

Circular

**(w.e.f. Academic Year 2018 onwards also
applicable as amended by Government)**

- (1) It is resolved that, Netaji Subhas University will follow reservation policy of the State Government for admission into various programs (UG/PG and Others):

ST – 26 %

SC – 10 %

OBC – 14% (Increased up to 27% w.e.f 2022)

EWS – 10% (These seats shall be supernumerary in nature)

Women – 3 %

Divyang Jan – 2%

Minorities – 4.5% (As per under Section 2(c) of National Commission for Minorities Act, 1992)

The caste certificate on the basis of which the student claims reservation should be issued by relevant authority of the Jharkhand Government.

- (2) It is resolved that in case of unavailability of the reserved category students, the vacant seats shall be filled up in the following manners :

(a) Against the vacant seats of ST, the SC candidates if available will be admitted.

(b) Against the vacant seats of SC the ST candidates if available will be admitted.

(c) If no candidate of SC and ST are available for admission, then the vacant seats will be filled following preference – (i) OBC (ii) General

(d) If no candidate of OBC is available for admission, then the vacant seats will be filled following preference by General category.

(e) If no candidate of reserved classes are available for admission then the vacant seats will be filled by General Category Students

(f) If no candidate of minorities / Divyang Jan are available for admission, then the vacant seats will be filled by others subject to approval of competent authority.

- (3) It is further resolved that as per provision of section 3 (9) and section 5 (4) of the Gazette of Jharkhand Government dated 24/09/2018 under the preview of Netaji Subhas University Act 2018 (Jharkhand Act No. 11, 2018) the reservation policy will be applicable subject to recommendation of admission committee.
