#### **Meeting Proceedings:**

The key decision of the meeting was to introduce **Outcome-Based Education (OBE)** in the Department of Commerce. The committee deliberated on the necessity of aligning the curriculum with industry expectations and academic advancements to enhance the learning experience of students.

To implement OBE effectively, the syllabus for **B.Com and M.Com** programs has been **reframed**, incorporating:

- **Programme Outcomes (POs)** – Defining the broad competencies that graduates should acquire.
- **Programme Specific Outcomes (PSOs)** – Outlining the domain-specific skills and knowledge required.
- **Course Outcomes (COs)** – Stating the expected learning outcomes for each course.

The faculty members presented the revised syllabus, ensuring that it adheres to national and international educational benchmarks. The committee extensively reviewed the proposed modifications and provided suggestions to further enhance the relevance and applicability of the syllabus.
