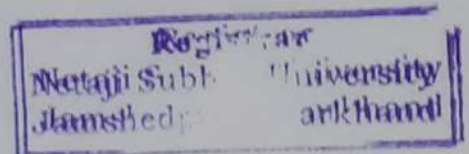

The meeting also discussed the following issues:-


1. A committee to be constituted for the compiling of the College manual.
