b) E-counselling services, offered through digital platforms, ensuring accessibility and flexibility for students.

c) Guidance and preparation resources for competitive examinations like MBA , Banking and SSC , thereby equipping the students with necessary tools and knowledge to succeed in such exams.

Responsibilities of the University:

The University agrees to facilitate these services:

a) Providing necessary infrastructure, such as venues for in-person counselling sessions.

b) Promoting the availability of these services among its students to ensure maximum participation.

c)The university agrees to help the service provider promote its competitive exam courses among its students.

d) The university shall allow the service provider to put up stalls at the premises to promote its competitive exam courses among the students.

e) The university shall facilitate the commute of students to the service provider to gain knowledge of competitive exams and career choices.

Duration

This MOU shall come into effect on 22nd January 2019, a working day, and shall remain in effect until terminated by either party based on the termination clause or at the completion of the five-year period.





Termination

Either party may terminate this MOU by providing written notice to the other party at least 30 days in advance. This ensures flexibility for both the University and the Service Provider to end the collaboration if deemed necessary.

Amendments

Any amendments or modifications to this MOU must be made in writing and signed by authorized representatives of both parties to ensure mutual agreement on any changes.




