- C. Existing/Proposed new Courses / Programs for academic affairs.
  - 6. A new course of two years LL.M-2 year has been proposed to commence from Academic session 2022-2023 and P. G Diploma in Cyber Law in upcoming Academic Years subject to decision of Hon'ble Chancellor.

The member of Board of Studies approved the syllabus of Two years LL.M-2 year with specialization in Corporate Law, Criminal Law and Constitutional Law and other.
