#### 4. Action Items & Next Steps

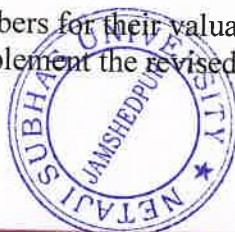
- The final approved syllabus will be circulated to all concerned departments and faculty members.
