In view of the on-going internship opportunities being provided to students of Academic batches as mentioned above, concerned students are advised to make a note of the following action points which is being implemented and will be followed with immediate effect:

1. Internship duration has been decided as follows in accordance to the course curriculum and further advice and discussion with the management, respective HoDs & Deans of various schools.

Time Duration: 45 days – 2 months

PG: MBA (2024-26)

UG: BBA/ B.Com/ Diploma (2023-2026)

Time Duration: maximum 6 weeks UG: B.Tech 4th Sem & 6th Sem

Please note that the internships start from the second week of May 2025. However, the internships need to be completed within the timeframe mentioned above and should not exceed beyond 15th of July 2025.

- 2. Students are advised to choose their specialization after a careful thought. No changes in specialization will be allowed going forward. The data captured in the shared spread sheet (circulated on student Whatsapp group dt. 22.04.2025) will be considered final and binding. If any student has missed to fill the shared spread sheet and his/her specialization is not known, it will be considered as not applicable. Based on the same, the specified individual will not be considered any internship or placement opportunities.
- 3. Internships should mandatorily be done in their area of specialization or academic stream and not in any other area. e.g., if a student has chosen Marketing as a Paper 1/ major specialization;

the internship is to be done in the same domain. Internships will be deemed invalid if a student fails to abide by the same.

- 4. NOC is mandatory if a student is enrolled in a non-university provided internship. If the student fails to inform the placement cell for any reason, the internship shall be considered as invalid. The information has to be provided to the placement cell latest by 10th of May, 2025.
- 5. Owing to a large pool of students, placement cell members are working rigorously to find internships where they can learn and develop their industrial acumen. Further to the same, internship opportunities shall be provided to all students which they may choose based on their interests. However, once any student is selected for any of the companies, he /she would be removed from our list and would not be allowed to apply for any further internship opportunities.
- 6. NSU and its placement cell expect their students to maintain a professional attitude as they are our brand ambassadors in front of the organization they associate with. Hence, if a student has applied for any specific opportunity and fails to attend the interview at the specified time, he/she will be blacklisted from all further internship Opportunities and will have to find an opportunity by him/herself. NOC will be granted to such students upon their request.
- 7. Upon selection by any internship organization, the specified student is supposed to join that organization itself. If he/she declines the opportunity, no further internship opportunities will be provided and students will have to find an Internship on their own.
- 8. Internship is not a negotiating platform. It should be assumed that the placement cell has already spoken with the company and discussed upon stipend (if any), A student can't suggest/advice/ negotiate upon the stipend rates. The JDs is being shared in class Whatsapp groups are final and should be read thoroughly before applying for the same.
- 9. Although we are trying to cater to the requests of students, the placement cell does not guarantee online/ offline internship according to student wishes. Although online internships have been taking centre stage in recent times owing to increased awareness towards workspace flexibility and dynamicity in the work environment, we urge the students to apply for offline internships too, to get a real feel of the corporate environment.
