The aforesaid University are herein after referred to individually and collectively as University.

Both Universities are jointly referred to as the "Parties" and individually referred to as the "Party" here in after and abbreviated as NSU & KU.

Preamble

WHEREAS, NSU and KU, Chaibasa have areas of common interest in multi-disciplinary domain, knowledge sharing among faculties for considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research. THEREFORE, NSU and KU, Chaibasa have decided to sign this Memorandum of Understanding (herein after referred to as MoU), which defines the framework for the cooperation of the two higher education institutes set out in the following sections.

ARTICLE 1: OBJECT

Both Universities agree to develop the following collaborative activities in the Academic areas of mutual interest.

Universities shall seek to promote:

A. Faculty/Scientist/Staff Exchange programs

- a) The exchange of faculties would mutually benefit both Universities.
- b) Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest.

- c) The exchange of academic materials and publications.
- d) Conducting lectures on a regular basis.
- e) Undertaking joint research.

- h) Supervising post-graduate students and conducting study tours.

Specific plan of actions will be promoted for each activity and setting forth detailed arrangements for collaboration. Terms and conditions for every visit, assignment or any such exchange, remuneration, travel allowance, and accommodation will be planned out mutually.

B. Student Exchange

A home institution refers to the institution where a student is a full-time student, A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

NSU and KU, Chaibasa agree that student exchange will be guided by principles listed below. Exchange students will be selected by mutual agreement between the home University and the host University.

- a. An exchange student will continue to be treated as full-time student at his/her home University.
- b. An exchange student will be considered as full-time "exchange" student at the host University.
- c. His/her programme of study at the Host University will be determined by mutual consultation between his /her academic advisor at the home University and his /her "interim" academic advisor identified by the host University.

- d. The host University will evaluate an exchange student's performance in each course or module and award them a letter of grade or marks.
- e. The home University may award credits to the exchange student. Credits earned at a host University, will be valid only if the home University has established correspondence between courses taken at the host University vis-a-vis those offered at the home University.
- f. If an exchange student has undertaken research, then the Host University will evaluate the exchange student's performance in the research, and issue a letter to that effect, as well as a technical report of the research will be carried out.
- g. If an exchange student has undertaken research, then the home University will take note of the performance and the technical report, then steps will be taken in accordance with its own procedures.
- h. NSU and KU, Chaibasa agree to provide suitable accommodation and food expenses for student exchange.
- i. To avail travel expenses, students can apply for existing funding programs at their respective home universities.
- j. The exchange students will pay tuition and other fees at their home University.

C. Other Areas of Understanding :

- a) To exchange information on research and educational programs.
- b) To exchange information on teaching, learning material and other literature relevant to their educational and research programs.
- c) To jointly organize short-term education programs on topics of mutual interest and to invite each other's faculty to participate therein.
- d) To organize joint seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein.

- e) To propose and engage jointly in research or training program sponsored by funding agencies, and to invite each other's faculty to participate therein.
- f) To exchange, on a reciprocal basis, students at Undergraduate, Post Graduate and Doctoral levels for limited period of time for purpose of education and /or research.
- g) The provision of cultural and intellectual enrichment opportunities for staff and students of both Universities.
- h) To use laboratory facilities in specific cases for a limited period.
- i) To permit students, staff and faculty members to use library facility.

NSU and KU, Chaibasa agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the both Universities. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Both Universities shall appoint one member of its teaching / research faculty to coordinate the programme on their behalf. Further, a coordination committee consisting of a programme coordinator from the side of KU, Chaibasa and a programme coordinator from the side of NSU, Jamshedpur will periodically review and identify ways to strengthen cooperation between the two Parties.

ARTICLE 3: CONFIDENTIAL INFORMATION

Both the parties of the MoU's do not absolve any confidential information during the research activity.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer

software, and any other industrial or intellectual property rights) developed jointly during the course of this MoU shall be vested in both Universities to this Memorandum.

Both Universities shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both Universities shall make joint applications for the registration of the same. Before any registration or commercialisation of intellectual property takes place, the Universities agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both Universities, such consent not to be unreasonably withheld.

Kolhan University, Chaibasa shall be free to use the results perpetually arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

ARTICLE 5: VALIDITY

The Memorandum shall remain in force for a period of 2 years commencing from an effective date. Both Universities may extend the term by written agreement signed by both parties after a review.

ARTICLE 6: TERMINATION

Either University may terminate the MoU by serving a written notice of one month in advance to the other University. Once terminated, neither NSU nor KU will be responsible for any losses, financial or otherwise, which the other University may suffer. However, NSU and KU will ensure that the provisions of this Memorandum shall continue to apply to all activities in progress until their completion.

ARTICLE 7: AMENDMENTS / MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by representatives of both the parties.

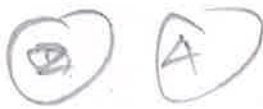



and

Netaji Subhas University (NSU) is a State Private University established by an Act in the year 2018 established Vide No. LG-21/2018-142 at Pokhari, East Singhbhum, Jamshedpur, Jharkhand promoted by Sitwanto Devi Mahila Kalyan Sansthan, Suraj Path, Baridih, East Singhbhum, Pokhari, Jamshedpur and registered under Patna Society Registration Act, 21, 1860 (Registration No. 209/1996-97 dated 11/12/1996).

Each referred to individually as a "Party" and together as the "Parties".

Objective: The MoU drawn up and agreed upon to establish academic and allied cooperation between Kalinga Institute of Social Sciences (KISS) Deemed to be University, Bhubaneswar, Odisha, India and Netaji Subhas University, Jamshedpur, Jharkhand, India.

ARTICLE-1. PURPOSE

ARTICLE-2. SCOPE/AREAS OF COOPERATION

OBJECTIVES

The MoU relates to proposed links between the KISS Deemed to be University, Bhubaneswar, Odisha, India and Netaji Subhas University, Jamshedpur, Jharkhand, India.

Both the parties propose to participate and co-operate in mutual discussions and joint activities with regard to the followings:

Establishment of Academic and Research partnership which provides opportunities for both the Universities to carry out and publish joint research papers, joint projects and joint patent.

Responsibilities:

Both the parties do hereby agree to undertake the followings:


- Joint research, including publications and other appropriate activities, between staff and/or students from each institutions
- Facilitates the exchange of staff, students and researchers for the purpose of teaching, study, research and extension activities
- Undertake academic and research work jointly on issues relating to socio-economic exclusions, deprivations and inclusive growth of tribal and other backward communities, dalit literature and culture and so on.
- Provide the laboratory, academic and research facility as well as infrastructure
- Provide administrative support for growth of academic and research
- Provide mentor advice and support to the other party for growth of its academic and research activities
- Identification of areas of possible mutual academic and research interest
- Identification of potential research opportunities and initiatives to take forward the activities
- The dissemination of information and the sharing of experiences among staff and students

Both parties also agree to encourage the following activities, in particular, to promote academic cooperation in the following areas:

- a) Institutional exchanges between students and staff;
- b) Organization of joint seminars, symposia, conferences, short courses and meetings on academic and research issues;
- c) Exchange of information pertaining to developments in teaching, student development and research activities and;
- d) Cooperation in any other areas as agreed to by both the Parties from time to time.

ARTICLE-3. DURATION, TERMINATION AND AMENDMENT

1. This MoU will be effective from the date of signing by both parties for a period of 3 years, and may be subject to extensions by mutual consent in writing.
2. Either party may terminate this MoU by giving Six (6) months advance notice in writing.
3. The provisions of this MoU may be amended at any time with the mutual consent of the parties in writing.
4. The amendment, termination and expiration of this MoU will not affect the terms of activities ongoing at the time of notification of amendment, termination or expiration, unless otherwise agreed upon between the two parties.

ARTICLE-4: INTELLECTUAL PROPERTY RIGHTS

4.1 Intellectual Property Rights (IPR) generated during the Research, under this MoU, shall be shared in accordance with the mutual understanding of the parties at the point of filing of the patent. General rules, however, could be the following:

4.1.1 Joint Intellectual Property ("Joint IP"): the Parties shall agree that the application for patent registration and/or any other registerable rights shall be filed jointly.

4.1.2 In the case of the IPR generated by Netaji Subhas University, Jamshedpur, Jharkhand, India, the University shall file, prosecute, maintain and extend patents or other appropriate register-able rights concerning such Joint IP and shall keep KISS Deemed to be University informed about the status of all such actions. Similarly, in the case of the IPR generated by KISS Deemed to be University, KISS-DU shall file, prosecute, maintain and extend patents or other appropriate register-able rights concerning such Joint IP and shall keep Netaji Subhas University, Jamshedpur, Jharkhand, India informed about the status of all such actions.


Both the parties shall execute necessary documents and provide assistance in order to protect the interest of both Parties under this clause.

4.1.3 Joint patents would be owned jointly and both parties would have equal ownership in the same.

4.1.4 Neither Party shall withdraw the application for any patent nor any other applicable registrable right filed pursuant to Section 4.1.3.

- 4.1.5 Both Parties shall have the right to use the Joint IP individually.
- 4.1.6 Parties shall take consent of the other before sublicensing the Joint IP, and pay the other a royalty depending on the valuation of their research contribution on mutually agreed price.
- 4.2 No Party shall acquire any ownership interest in any other Party's Background rights while performing the joint Research. Respective Party shall remain owners of their respective Background Rights.

ARTICLE-5: CONFIDENTIALITY

- 5.1 During the validity of this MoU and three [3] years thereafter, faculty of Netaji Subhas University, Jamshedpur, Jharkhand, India undertakes on its behalf and on behalf of its students/employees/associates/representatives and KISS Deemed to be University undertakes on behalf of its students/employees/ associates/ representatives to maintain strict confidentiality and prevent disclosure thereof, of all the Confidential Information and data exchanged/ generated pertaining to Academic and Research work under this MoU for any purpose other than in accordance with the MoU.
- 5.2 Notwithstanding anything stated in this MoU, Netaji Subhas University, Jamshedpur, Jharkhand, India, faculty members/associates involved and KISS Deemed to be University's faculty members/associates/representatives shall not in any event disclose confidential information related to Intellectual Property to any third party.
- 5.3 The obligations set forth in this clause shall survive any termination or expiration of this MoU for a period of three years.

ARTICLE-6. SPECIAL PROVISIONS

1. Modalities of each type of collaboration, associated activities and financial aspects shall be mutually agreed upon on a case-by-case basis in separate Memorandum of Agreements (MoA).
2. Each party will take approval from the other party in writing to use the latter's name and logo for the activities here under on a case-by-case basis.
3. Both parties here shall do their utmost to ensure the smooth and efficient implementation of the mentioned programs.
4. The two parties will consult with each other for any subsequent associated agreement informally and attempt to resolve disputes or misunderstandings that may arise in the administration of this MoU or any subsequent associated agreement informally.
5. In the case of any legal dispute pertaining to the Articles 1 through 6 above, the seat of the adjudication shall remain in Bhubaneswar, Odisha, India.

(1) ISDC GLOBAL SERVICES LIMITED, a company registered in England and Wales (company registration number 10990346) having its Registered Office at No. 20-22 Wenlock Road, London, England, N1 7GU (the “**Supplier**”) and

(2) NETAJI SUBHAS UNIVERSITY, JHARKHAND, a private university situated at RVSCET, Pokhari, near Bhilai Pahadi, Jamshedpur, Jharkhand 831012 (the “**Client**”).

Each is referred to as “Party” and both together as “Parties”

RECITALS:

(1) The Supplier is an expert in the providing learning platforms for professional education and desires to associate with academic institutions and education management establishments for allocation of the learning platform to professional program students.

(2) The Client, possessing necessary skill and experience in imparting training for professional students and having adequate facilities to carry out such training, desires to share the learning platform developed by the Supplier for benefit of their students.

NOW THEREFORE, in consideration of the mutual promises herein contained, the Parties agree as follows:

1. DEFINITIONS

In this Agreement, except where the context otherwise requires, the following words shall have the meaning as given hereunder.

- **Agreement:** means this agreement together with any Schedule, as may be amended from time to time in writing by the Parties.
- **Business Day:** means any day which is not a Saturday, a Sunday or a bank or public holiday in England.
- **Charges:** means the fees payable by the Client in respect of the provision of each Platform and by the Supplier as calculated in accordance with the relevant Platform Schedule.
- **Commencement Date:** means the date of execution of this agreement.

- **Confidential Information:** means all and any commercial, financial, marketing, technical or other information, know-how or trade secrets in any form or medium belonging to or disclosed by one of the Parties to this Agreement or obtained under or in connection with this Agreement (whether disclosed or obtained before or after the date of this Agreement), together with any copies, summaries of, or extracts from, such information in any form or medium or any part(s) of this information and which is designated as confidential or which is manifestly confidential.
- **Platform – ISDC Pro:** means a pre-populated learning platform supplied by the Supplier towards the qualifications set out in a Platform Schedule.
- **Platform Duration:** means the duration of Client Platform access, as set out in a Platform Schedule.
- **DPA:** means the Data Protection Act 1998 (as amended or re-enacted from time to time).
- **IPRs:** means any rights (including moral rights) subsisting in any patent, petty patent, trade mark, service mark, get-up, design, copyright, computer software, databases, know-how and other trade secrets, trade or business names, domain names and other industrial or intellectual property rights or other forms of protection having equivalent or similar effect subsisting anywhere in the world, in each case whether registered or unregistered and including applications for registration.
- **Order:** means a booking for any Client learning platform.
- **Schedule:** means a schedule to this Agreement.
- **Coupon Rate:** means the fee to be charged by the Client from the students for booking of the learning platform.
- **Services:** means the delivery of pre-populated learning Platforms by the Supplier to the Client.
- **SLA:** means the service level agreement set out in Schedule 3.
- **Start Date:** means the date on which the relevant Platform is due to commence.
- **Supplier Group:** means the Supplier and any holding company of the Supplier and any corporate body of that holding company that is a group undertaking of such holding company from time to time, the terms “holding company”, “body corporate” and “group undertaking” having the meanings given to them in the Companies Act 2006).
- **Term:** means the duration of this Agreement as set out herein.
- **White Label Permit:** Permit given by the Supplier to the Client to share the learning platform displaying therein the name and logo of the Client.

2. Term and Coverage of this Agreement.

2 (1) Duration: This Agreement shall commence on the Commencement Date and shall continue for a period of three years, if not terminated otherwise in accordance

with the terms of this Agreement, and on the expiry of such period this Agreement shall automatically terminate (the "Term").

2 (2) Territorial Coverage: This agreement grants a **non-exclusive** licence to the Client for usage and sharing of the learning platform provided by the Supplier within the territorial limits of India only.

3. Structure of this Agreement and Appointment and Orders

3 (1) This Agreement governs the overall relationship of the Parties in relation to providing Services by the Supplier to the Client for the benefit of the Students.

3 (2) The Supplier hereby appoints the Client for the term of this agreement as specified above to provide the Services and the Client hereby accepts such appointment.

3 (3) Access to the learning platform for the students of the Client shall be facilitated by the Supplier against specific orders and payments made by the Client during the Term.

3 (4) Client Admin and Management access Control shall be facilitated by the Supplier exclusively to the Clients who opt for White Label Permit.

3 (5) The terms of this Agreement shall apply to each Order placed by the Client unless otherwise agreed between Supplier and Client.

3 (6) If the Client cancels an Order, whether in whole or in part, in writing prior to sharing the access by the Supplier, the Client will be entitled for full refund of Charges paid and no other charges shall be payable in relation to the whole or part so cancelled.

3 (7) If the Client cancels an Order, whether in whole or in part, after sharing the access by the Supplier, the Client shall not be entitled for any refund.

3 (8) The Supplier shall comply with its obligations under the SLA (which shall include taking such "Corrective Action" as is required) and the reporting schedule set out in Schedule 3.

4 Intellectual Property

4 (1) The Parties acknowledge that all IPRs that pre-exist the Commencement Date will remain vested in the Party in whom they were vested as at the Commencement Date and that the IPRs in all enhancements and modifications thereto will vest in the owner of the relevant pre-existing IPRs.

4 (2) The Supplier hereby grants to the Client and each relevant Student a non-transferable, non-exclusive royalty free license to use the IPRs in the Platforms and

Study Materials (and, in each case, any enhancements or modifications thereto) during the Term and thereafter, for the purpose of enabling that Student to participate in the Platform and to use the same for that Student's own educational purposes.

4 (3) The Supplier is not responsible for any third-party IP a Client may use within, or in conjunction with, a ISDC Learning Platform. ISDC' rights to use third-party IP within the learning Platform is a non-transferable right.

5. Branding

5(1) The Client shall be permitted by the Supplier to use the brand logo of "ISDC Pro" in their promotional materials, brochures, leaflets and advertisements subject to the provision that that the draft of such materials and advertisements are approved by the Supplier. The Client shall submit drafts of such materials and advertisement Matters for prior approval of the Supplier.

– Payment Terms

– (1) In consideration of the provision of the Platforms by the Supplier, the Client shall pay to the Supplier, the Fee and Charges in accordance with the terms set out herein and in accordance with Schedule 2 of the agreement.

– (2) The Charges are (i) exclusive of any VAT and other sales taxes that may fall due, and the Client shall pay all such sales taxes at the applicable rate in addition to the Charges and in the same manner, subject to the Client receiving a valid VAT invoice, and (ii) inclusive of all other expenses and charges for delivery of the Platforms and any transactions charges and duties.

– (3) Discounted Rates specified in Pricing Schedule (Schedule – 2) is the rates applicable only to the Clients and the Clients are explicitly prohibited from promoting the fee below to the stipulated Coupon Rate from the students in order to ensure uniform rate of fee to all students.

7. Warranties

(1) The Supplier warrants and undertakes to the Client that:

- a) it has full capacity, power and authority to enter into, deliver and perform its obligations under and in accordance with this Agreement (and all other documents to be entered into by it under this Agreement);
- b) it will it will perform its obligations under this Agreement, including delivery of the Platforms and preparation and update of all Study Materials contained within the platform, with all professional skill, care and diligence, in a good and timely manner and at all times in accordance with this Agreement, including the Platform Schedule and any applicable SLA;
- c) it will immediately inform the Client of any changes in the way the Supplier proposes to deliver the Services;

- d) The Platform will be delivered in such a way to allow each Student the opportunity for that Student to work towards and achieve the award of the top grade available to that Student for the relevant qualification. No other materials, other than the Study Materials within the relevant Platform, will be required by a Student to achieve such top grade;
 - e) It has the right to provide the Study Materials within the platform and that the use by the Client or Students of the Study Materials in accordance with this Agreement will not infringe the IPRs of any third party.
- (2) The Client warrants that it has full capacity, power and authority to enter into, deliver and perform its obligations under and in accordance with this Agreement (and all other documents to be entered into by it under this Agreement).

– **Termination**

- (1) This agreement, any Platform for any Intake and/or any Order may be terminated immediately by a Party, if the other Party:
- (a) ceases trading, admits that it is, becomes or is declared unable to pay its debts as they fall due within the meaning given by Section 123 of the Insolvency Act 1986, becomes or is declared insolvent, has a liquidator, receiver or administrative receiver appointed or passes a resolution for winding up (otherwise than for the purpose of a scheme of solvent amalgamation or reconstruction where the resulting entity is at least as credit worthy as the other Part and assumes all the obligations of the other Part under this Agreement) or if a court having proper authority makes an order to that effect;
 - (b) materially breaches this Agreement, except that where such breach is capable of being remedied, this Agreement may only be terminated where the Party in breach has failed to remedy the breach within 10 days of receipt of written notice of the breach. Notwithstanding the foregoing, this Agreement can be terminated immediately where the breach is persistent. A breach of this Agreement will be persistent where the Party in breach has already been asked to remedy the breach but it has recurred not less than two (2) further times in any continuous period of twelve (12) months.

– **Data Protection**

- (1) The Parties shall comply with their respective obligations under the DPA and all related legislation.
- (2) The Supplier agrees that, to the extent the Supplier receives, or otherwise has access to, any personal data regarding the Client's individual personnel or Students in connection with this Agreement, then it shall:

- i. use, store use, store and otherwise process such information only to the extent necessary to carry out its obligations under this Agreement and not otherwise (unless instructed by the Client in writing);
- ii. keep personal data confidential and not disclose it to any third parties unless the Client gives prior written consent and it is disclosed by the Supplier solely in connection with providing the Services under this Agreement and provided such third parties have agreed in writing to be bound by the provisions of this clause;
- iii. without limiting the foregoing, the Supplier shall comply with all applicable privacy laws and regulations.
- iv. The Supplier, with the Client's permission, may use aggregated anonymous student data to report on trends and insight across the total Client base;

Confidentiality

Each Party undertakes to the other that during the Term and thereafter it shall keep secret and shall not without the prior written consent of the other Party disclose to any third party (except to its legal and professional advisors) any Confidential Information learned by the recipient Party or disclosed to the recipient Party by such other Party pursuant to or otherwise in connection with this Agreement.

1. Indemnity

1 (1) Neither Party shall be liable to the other in respect of any loss of revenue, profits, business or data, in each case, whether direct or indirect, or for any indirect, special or consequential loss, irrespective of whether such loss was foreseeable or whether the Party has been advised of the possibility that such loss may be incurred.

12. General

12 (1) Each Party shall observe and comply with all applicable laws (including but not limited to the Bribery Act 2010), rules, regulations, directions, codes of practice or guidelines imposed by national law or any competent authority which are applicable to either Party.

12 (2) This Agreement and any non-contractual obligation arising out of or in connection with this Agreement and any dispute shall be governed by English law. The courts of England and Wales will have exclusive jurisdiction to settle any disputes

Which may arise out of or in connection with this Agreement (including without limitation) in relation to any non-contractual obligations). The Parties irrevocably submit to that jurisdiction.

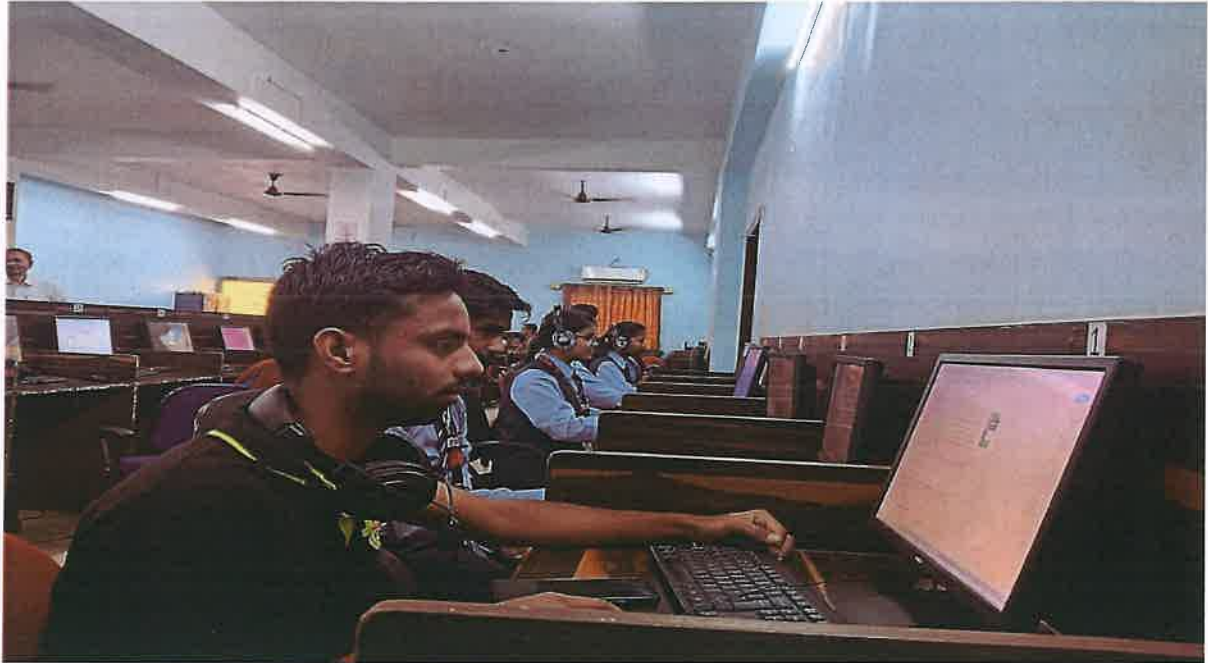

CL.5 DURATION/VALIDITY/TERMINATION AND RENEWAL:

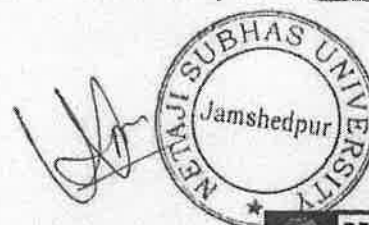

ARTICLE 4.3: Other Areas: (See list in Annexure – II)

“Netaji Subhas University, Jamshedpur, Jharkhand (India)” and “Dr. Shivanand Nautiyal Govt. P.G. College, Karanparayag, Chamoli Uttarakhand (India)” agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 5: DURATION/VALIDITY/TERMINATION AND RENEWAL

The Memorandum shall remain in force for a period of Five (05) years commencing from effective date. However, this period may vary from area of collaboration and collaborative programmes. Institutions may extend the term by written agreement signed by both after review.

Any MoU between NSU and any other International or National Higher Education Institution may at any time during its period of validity, be terminated by one of the parties upon prior notice to the other party in writing not later than six months before the termination date. However, both parties will arrange six monthly mutual meeting to discuss the proper implementation and goal(s) achieved during that period. The NSU monitoring committee will consist of the following members:

1. Registrar (NSU) or its nominees and Registrar(other side) or its Nominee as Chairperson
2. Two Witnesses from Both sides.

The parties may with the mutual consent further extend the duration of collaboration.

ARTICLE 8: CONFIDENTIALITY

For reasons of sensitivity, the privacy of the individuals or the interests of the NSU; Agreement of MoU needs to enter into undertaking of confidentiality. Before any assurances of confidentiality are provided to a SECOND PARTY, the legal situation must be checked by the Registrar office of the NSU. The confidentiality of such Memoranda must be finally determined by the Registrar on advice from the respective Dean/Head of the School/Department taking into account the NSU's obligations under the current Indian legislations.

ARTICLE 9: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum and cannot be shared with third party unilaterally.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialization of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be processes with the prior written consent of both institutes. However, such consent not to be unreasonably withheld.

NSU shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, and publication purposes without the payment of royalties or other fees to the other party.

ARTICLE 10: ARBITRATION CLAUSE/LEGAL LIABILITY CLAUSE

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the law of the host countries and rules and regulations of the institutions. Nothing in this Memorandum shall be construed as creating any legal relationship between the institutes. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration. In case, there be a dispute/differences of opinion relating to any aspect of academic, research and administrative cooperation,






Concerned faculty/Head/Dean/Director/Registrar/Vice-Chancellor of the, NSU and Chamoli Uttarakhand (India) will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.

ARTICLE 11: TERMINATION OF MOU

The MOU will be terminated with mutually consent with prior notice of 60 Days.

- vii) If an exchange student(s) has/have undertaken research, then the host institution "B" will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out.

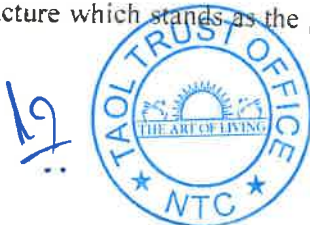

4. Details of Understanding:

The Partners, after due consideration of various aspects, have arrived at the following understanding in respect of the programs mentioned in the earlier paragraphs.

TAOL undertakes to impart specifically the following program:

Youth Empowerment Skills Program (YES!+) for students (18+ yrs) and Faculty Development Program for teachers and staff

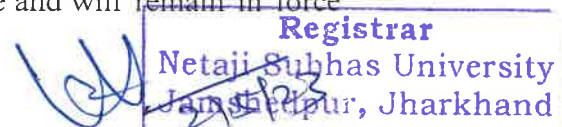
- i. YES!+ program runs over for 3-6 consecutive days for 3-6 hours every day. It can be customized for groups as per their constraints.
- ii. The FDP program runs over for 4 consecutive days for 03 hours every day.
- iii. All NSU students and staff are covered under this agreement.
- iv. Reconnect sessions of duration 1-2 hours will be conducted by TAOL faculties once a month for the graduates of the YES!+ and FDP programs.
- v. Any monetary contribution towards the offered programs shall be borne by the students/faculty/staff on a voluntary basis.
- vi. The financial contribution shall be paid by the participants on a voluntary basis to TAOL before the commencement of the program.

NSU shall:

- i. Provide a clean, well-ventilated hall large enough to comfortably accommodate participants. Audiovisual equipment could be provided. Other logistical support, e.g., drinking water facilities at venue, whiteboard, markers etc. shall also be provided.
- ii. Give permission to TAOL faculty to conduct informational seminars on campus to raise awareness among the students/faculty of NSU about the YES!+/FDP. Interested students/faculty shall enroll in the program on a voluntary basis.

- iv. Provide in-city conveyance for TAOL faculty during the YES!+/FDP program.

5. Date of Effect:

This Agreement will come into effect from the date of signature and will remain in force for three years.



6. Modification:

The Agreement may be amended in writing by mutual consent between the two Partners.

7. Confidentiality:

Absolute confidentiality of the information exchanged between the Partners concerning the subject matter of this Agreement shall be strictly maintained.

8. Termination:

Either Partner may, without any termination obligations and liability, terminate this agreement for any reason by providing notice in writing of at least 30 days to the other Partner.

9. No Legal Obligations:

The Partners agree that provisions contained in this Agreement do not create any legal obligations between the Partners, save for the confidentiality provisions and Termination provisions in this Agreement.

10. Assignment:

This Agreement cannot be assigned to any third party, without the prior written consent of the other Party.


11. Limitation of Liability:

Except for claims that may arise pursuant to Confidentiality and termination clauses, in no event shall either Party be liable to the other for any damages including, without limitation, direct, speculative, indirect, incidental, special or consequential damages in connection with this Agreement.

12. Governing Law and Jurisdiction:



The aforesaid institutions are hereinafter referred to individually as institute and collectively as institutes or University.

Preamble

WHEREAS, NSU and NSMCH, Bihta, Patna have many areas of common interest in multi-disciplinary knowledge sharing among faculties for considerable advantage may be gained from their pursuit on a collaborative basis in the fields of academics, education and research in the field of Pharmaceutical Education. NOW THEREFORE NSU and NSMCH, Bihta, Patna have decided to enter into this Memorandum of Understanding (hereinafter referred to as MoU), which defines the framework for the cooperation of the two higher education institutes set out in the following sections.


ARTICLE 1: OBJECT

Both Institutes agree to develop the following collaborative activities in the academic areas of mutual interest.

The two institutions shall seek to promote:

a. Faculty/Scientist/Staff Exchanges

- (i) The exchange of faculty to the mutual benefit of both institutions,
- (ii) Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- (iii) The exchange of academic materials and publications,
- (iv) Conducting lectures

- (v) Undertaking joint research,
- (vi) Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills,
- (vii) Participating in seminars, symposiums, and other types of academic discussions
- (viii) Conducting study visit and joint consultancy work.

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning salary, travel funding, health insurance, and housing will be worked out.

b. Student Exchange

NSU and NSMCH, Bihta, Patna agree that student exchange will be guided by principles listed below A home institution refers to the institution where a student is a full-time student, A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme of study or research.

- i) Exchange students will be selected by mutual agreement between the home institution and the host institution.
- ii) An exchange student will continue to be treated as full-time student at his / her home institution.
- iii) An exchange student will be considered as full-time "exchange" student at the host institution.
- iv) His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.
- v) The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect.
- vi) The home institution may award to the exchange student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at the host institution vis-a-vis those offered at the home institution.

- vii) If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical report of the research carried out.
- viii) If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- ix) NSU and NSMCH, Bihta, Patna agree to provide suitable accommodation and living expenses for student exchange.
- x) To avail travel expenses, students can apply for existing funding programs at their respective home universities.
- xi) The exchange students will pay tuition and other fees at their home institution.

c. Other Areas:

- (i) To exchange information on research and educational programs,
- (ii) To exchange information on teaching, learning material and other literature relevant to their educational and research programs,
- (iii) To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein,
- (iv) To organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein,
- (v) To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein,
- (vi) To exchange, on a reciprocal basis, students at Undergraduate, Graduate and Doctoral levels for limited periods of time for purpose of education and /or research,
- (vii) The provision of cultural and intellectual enrichment opportunities for staff and students of both institutes,
- (viii) To use laboratory facilities in specific cases for a limited period,
- (ix) To permit students, staff and faculty members to use library facility.

NSU and NSMCH, Bihta, Patna agree that detailed terms and conditions that guide each activity identified above will be determined separately and agreed upon by the two institutions. These terms shall include a technical description of the proposed activity, financial arrangements, and person(s) responsible for its implementation.

ARTICLE 2: COORDINATION

Each institution shall appoint one member of its teaching/research faculty to coordinate the programme on its behalf. Further, a coordination committee consisting of a programme coordinator from the side of NSMCH, Bihta, Patna and a programme coordinator from the side of NSU, Jamshedpur will periodically review and identify ways to strengthen cooperation between the two Parties.

ARTICLE 3: CONFIDENTIAL INFORMATION

Both the parties of the MOU's does not absolve any confidential information during the research activity.

ARTICLE 4: INTELLECTUAL PROPERTY RIGHTS

Ownership of any intellectual property (including but not limited to confidential information, know-how, patents, copyrights, design rights, rights relating to computer software, and any other industrial or intellectual property rights) developed jointly during the course of this MOU shall be vested in both institutes to this Memorandum.

Both institutes shall have the joint right to determine the commercial exploitation and disposition of such intellectual property, and both institutes shall make joint applications for the registration of the same. Before any registration or commercialisation of any intellectual property takes place, the institutes agree to reach a separate agreement covering issues such as exploitation rights and revenue sharing.

Any publication regarding such intellectual property shall only be possible with the prior written consent of both institutes, such consent not to be unreasonably withheld.

NSMCH, Bihta, Patna shall be free to use perpetually the results arising out of the collaborating activities for its own internal teaching, research, educational, clinical and publication purposes without the payment of royalties or other fees to the other party.

ARTICLE 10: DISPUTE RESOLUTION



This MOU is entered into on 07th January, 2022 by and between Netaji Subhas University, Jamshedpur and Rambha College of Education, Gitilata, Jamshedpur.

The aforesaid institutions are herein after referred to individually as institute and collectively as institutes.

Objective:

This memorandum of undertaking (herein after referred to as the MOU) intends to set out the general principles of mutual co-operation in the field of teaching and research, according to which the two sides may jointly identify areas of mutual interest and carry out cooperative activities. The objectives of the MOU are:

1. To promote and enhance academic interest
2. To provide for implementation of quality education
3. To promote research/continuing education activities between the institutions.
4. To exchange services of faculties, experts and administrative staff.
5. To Jointly organize conferences / seminars/workshops / and symposia on matters of mutual interests.

Area of Collaboration:

1. On need basis both the colleges may exchange their faculties to improve the teaching and learning process for mutual interest.
2. Provide academic interactions by delivering special lectures on topics of relevance.
3. Provide necessary help in organizing workshops / conferences / seminars and Personality Development Programs for enhancement of skills in respect of faculties, staff and students of both the colleges.
4. To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein.
5. The provision of cultural and intellectual enrichment opportunities for staff and students of both the colleges.

Co-ordination:

Both the institutions shall appoint one member of its teaching faculty to co-ordinate the program on its behalf.

Confidentiality:

The Netaji Subhas University, Jamshedpur agreed to hold in confidence all information (data designated by the institutes) as being confidential which is obtained from either institutes or created during the performance of the MOU and will not disclose the same to any third party without written consent of either institutes.

Validity:

The Memorandum shall remain in force for FIVE years commencing from the effective date Institutions may extend the term by written agreement signed by both after review.

Termination:

Either institution may terminate the MOU by giving written notice six months in advance to the other institution. Once terminated, none of the institutes will be responsible for any losses, financial or otherwise, which the other institutions may suffer. However, all will ensure that the provision of this Memorandum shall continue to apply to all activities in progress until their completion.

Amendments/Modifications:

This MOU may be amended or modified by a written agreement signed by the representatives of both the institutes.

Adherence to Laws:

Participating faculties, staff and students involved in any activities under this Memorandum must adhere to the laws, rules and regulations of the institutions. Both the institutes welcome the establishment of this Memorandum for co-operation and jointly agree to the provisions as set out above.
