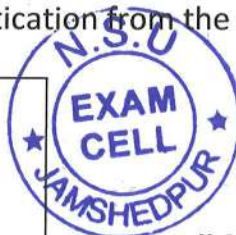
1. In case of stay out/ walkout /mass scale of unfair means, there will be no re-examination and Zero marks will be awarded in that paper.
